



**MLS FEE WAIVER FOR UNLICENSED INDIVIDUAL**

This AGREEMENT is made and entered into by the undersigned party ("Individual") in conjunction with Participant's request for exemption from NTREIS MLS fees.

1. The Individual named below shall be granted access to NTREIS MLS for the purpose of supporting one or more NTREIS subscribers and be exempt from NTREIS MLS subscription fees if such Individual meets any one or more of the requirements set forth below.
2. Such exemption is effective for the remainder of the *calendar year* in which the Waiver form is filed with Individual's MLS Provider Association, unless terminated sooner. The exemption for any Individual shall automatically be revoked upon that Individual's utilization of the NTREIS MLS in any manner (except as specified below).
3. For the purposes of this agreement, utilization of the NTREIS MLS is further defined, but not limited to, the following actions: Use of any NTREIS MLS system (on-line or off-line) and/or Offering NTREIS benefits to real property owners.

If the Individual utilizes the NTREIS MLS except as specified, the NTREIS MLS Participant is subject to a fine of \$50 per day, plus any additional fines, dues and payments that may be established by the NTREIS MLS Provider Association.
